



- Any addition, deletion or modification of any clause of the procurement terms & conditions of PMD by vendor will not be acceptable and may lead to rejection of the bid.
- Only registered suppliers, who are on Active Taxpayer List (ATL) of FBR are eligible to participate in tender. Please attach GST, NTN and ATL Certificates with Technical Offer.
- 3. The supplier is well established firm / company in the business of relevant field with sound financial status.
- The contract will be executed and handed over in satisfactory conditions up to the entire satisfaction of PMD.
- The bidder is required to furnish in form of pay order equivalent to 2% of the total bid price as Earnest Money in favour of "Director General Meteorological Services, Karachi. Any bid not accompanied by Earnest Money shall be rejected without any right of appeal.
- 6. Part / Advance payment is not allowed.
- 7. After opening of bids PMD, Karachi will examine the bid completeness as per tender documents.
- 8. Purchase order(s) will be awarded to the lowest and technically recommended bidder (s) on the basis of item wise/ subtotal wise/ grand total wise according to the nature of item.
- 9. PMD, Karachi will follow the PPRA rule of Single stage two envelope procedure:

14. If the delivered goods / services are not according to the required quality standards/specification, the same shall be liable to be rejected after inspection. The vendor would be required to supply as per requirements mentioned in Quotation, otherwise the purchase /work order will be cancelled with confiscation of carnest money.

- 16. Payment will be made on submission of Invoice in the name of "Pakistan Meteorological Department, Karachi" with GST invoice and copy of delivery challan (s) after the complete order has been supplied, inspected and accepted which includes delivery / installation and PMD acceptance / inspection thereof.
- 17. All the prices should be quoted on F.O.R. (Pak Rupees).
- 18. All prices should be valid for 90days, withdrawal or any modification of the original offer within the validity period shall entitle PMD to forfeit the earnest money in favour of the PMD and /or put a ban on such vendor participation in PMD tenders/ works.
- 19. It is the sole responsibility of the agent/ supplier/ manufacturer to comply with the applicable laws, be national or international.
- In case of any dispute, decision of the Chairman Purchase Committee will be final and binding upon the parties.
- 21. The PMD reserves the right to modify the quantities of goods / services at any time before the award of purchase / work order.

#### 22. Criteria for Technical Evaluation:

- i. The firm / supplier must be registered with GST/ Income Tax Department.
- ii. The firm / supplier must be included in Active Taxpayer List.
- iii. The firm / supplier must not be black listed by procuring agency / Govt. Office.
- During the technical evaluation no amendments in the technical proposal shall be permitted.
- Technical Evaluation will be done on the basis of detailed specification / sample provided, any offer/ sample not meeting the standard shall be rejected
- vi. 2% Earnest money must be deposited in the form of Pay order/ Bank Draft.
- vii. After the evaluation and approval of the technical proposal PMD, shall at a time within the bid validity period, publically open the financial proposals of the technically accepted bids only. The financial proposals of bids found technically non-responsive shall be returned unopened to the respective bidders.

#### 23. General or Special Conditions of contract clause:

- Purchase / work order (s) will be awarded on item wise basis as mentioned in form of quotation.
- ii) In case of placement of contract supplier is required to pay STAMP DUTY to Government of Sindh or require to submitted STAMP PAPER @0.35% of the contract value to this office under Article 15(a) of the Schedule to the Stamp Act, 1899.



3) Bidding Procedure: Single-stage two envelops i.e. Technical and Financial.

The bid submitted by the bidder shall comprise of two envelops submitted Simultaneously, one containing only the **Technical Proposal** and the other one

Financial Proposal.

 Technical Proposal: Must contain Original Proforma Invoice from their Principal showing complete specification of the quoted item, copy of CNIC of the Proprietor or Managing Director, copies of NTN and GST certificates, Original Pay order of the 2% earnest money in favour of Director General, Meteorological Services, Karachi and all other desired documents.

Financial Proposal: Must contain Price proposal/ORIGINAL PROFORMA
 INVOICE on Principal's letterhead and other below mentioned desired documents.

#### 4) SPECIAL INSTRUCTIONS:

- i) Validity: Offer should be valid for 90 days from the date of opening of tender.
- ii) Earnest Money: Tenderers should furnish Earnest Money @ 2% of quoted price in the shape of Pay Order/Bank Draft only from scheduled Bank in favour of Director General, Meteorological Services, failing which offer will not be entertained. Insufficient Earnest Money will not be acceptable. Earnest Money of the successful bidder will be converted into Security Deposit and the successful bidder will further be required to deposit 3% of the balance of the total value of the Contract placed with him/them as Security Deposit within 5 working days of the date of issue of Contract. In case of non-deposit of balance Security Deposit it will be concluded that the successful bidder has failed to honor the contract and will be liable to further proceeding as a defaulter.
- iii) Successful bidders are required to pay an amount equivalent to 0.35% of the total contract value including all taxes to the treasury office of Government of Sindh under Article 15 (a) of Stamp Act, 1899 or required to submit STAMP PAPER of the same value to this office for the issuance of contract.
- iv) Tenderers should indicate their Income Tax Number/ G.S.T. No. and National Tax Number. (Copies must be enclosed).
- v) Tenderer should mentioned the Manufacturer's Name, Brand and Country of Origin in their offer.
- vi) Change of Suppliers/Maker's Name, Country of Origin or any of the conditions the quotation will not be allowed and accepted subsequent to the opening of the tender or even after placement of contract unless asked for by the purchaser.
- vii) Tenderer must confirm in their offer that the packing offered is strong enough to withstand transportation by sea, Air, Rail and Road and also the usual transportation handling if required for such store.

- x) Shipment of Government consignment are restricted to Pakistan National Shipping Corporation or their chartered Vessels. Supplier must give one month prior intimation to the Agent of the Pakistan National Shipping Corporation.
- xi) Tenderers are required to confirm tender enquiry specification in all respects and furnish photocopy of N.T. Certificate and Sales Tax Registration Certificate alongwith offer.
- xii) The quantity may be increased or decreased at the Buyer's option.
- xiii) Tenderers should note that if the stores inspected and released by the Inspection Authority Officer, are rejected by either the consignee or the actual consumer /user and on re-inspection of same by the Inspection Authority, it is concluded that the rejection is justified, the terms and conditions of contract applicable. The decision of the Inspection Authority regarding such rejection will be final.
- xiv) Tenderers are required to submit genuine offers after fulfilling the requirements of the Tender Enquiry.
