I have been directed to say that this Court intends to borrow services of an expert of Civil Work, working in the Government departments in BPS 18/19, for his appointment ON DEPUTATION BASIS against the post of Project Director (BPS-19). 03. The Officer so appointed will give his expert opinion in all Civil Works of this Court and official Residences of the Hon'ble Judges, and oversee all such Civil Works related to the building project of this Court, mostly carried out by Pak.PWD.

It is, therefore, requested that detailed C.V of a suitable officer of BPS-18/19 of your esteemed organization, eligible for the subject post, may be forwarded to this Court preferably within a Week for consideration of his name for appointment in this Court against the above mentioned posts on deputation basis, on standard terms and conditions.
