

**NOTIFICATION**

SRO. 291(I)/2023:- In exercise of powers conferred by sub-rule(2) of rule-3 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, the following amendments shall be made in the uniform Recruitment Rules of Ministerial Posts notified by Establishment Division vide SRO. 139 (I)/ 2012, dated 31<sup>st</sup> January, 2012 as amended from time to time, applicable on all Ministries/ Divisions/ Departments of Federal Government:-

In the aforesaid Recruitment Rules:-

- (i) The "Words", "Brackets" & "Figures", "L.D.C (BPS-09)" & "U.D.C (BPS-11)", shall be substituted with "Words", "Brackets" & "Figures", "L.D.C (BPS-11)" & "U.D.C (BPS-13)" wherever occur.
- (ii) In Rule 3 (Condition for Promotion), against Sl. No. 4, under column 3 the existing entry shall be deleted and substituted by "Employees holding posts in BPS-10 and below"
