67th PROFICIENCY TEST IN SHORTHAND AND TYPEWRITING FOR GRANT Subject: -OF PROFICIENCY ALLOWANCE EQUIVALENT TO TWO INCREMENTS.

Secretariat Training Institute is planning to schedule 67th proficiency test for Assistant Private Secretaries (APSs), Stenotypists and LDCs at its campus, H-9, Islamabad during the month of September, 2024.
